### Construction Specifications:

All cabinet fronts are 16 gauge cold rolled steel welded to 22 gauge cold rolled steel tubs. Fronts are baked white enamel over rust inhibiting phosphate treated steel. All fronts are of radius corners except the Apex 5lb #516, 517, 518 have a 1" square trim. The #304 stainless steel satin finish #4 fronts are adjustable to the tub. Full stainless steel cabinets are welded.

To comply with ADA Guidelines, Strike First Extinguishers and Cabinets offer handles,

brackets and return trims according to instruction provided by installer. For ADA compliance follow the specification ordering process dimensions in our catalog. Proper installation in accordance with the ADA Guidelines is the sole responsibility of the installer. 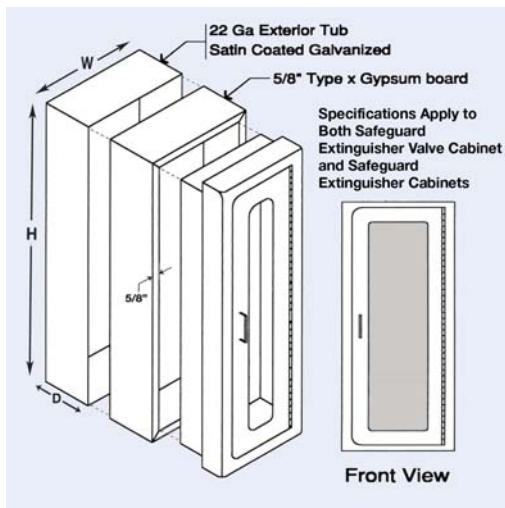
